

## 2024 PEAK PRODUCER & EXECUTIVE FELLOWSHIP RULES & CONDITIONS

Please read and abide by the rules and conditions as specified. The Application Form (via Google Forms), and Rules & Conditions Form, must be completely filled out. Any submission that does not follow the rules and guidelines will be disqualified. No submission will be returned.

Submission Period will run from **September 2** through **September 16, 2024**.

1. The entrants and submissions should be consistent with PEAK's mission to champion diversity by educating, connecting, and empowering Pacific Islander artists and leaders in entertainment and media.
2. Entrants must be 18 years or older.
3. All Entrants must have the ability to legally pursue and accept paid work in the United States.
4. If selected, all Entrants must provide their own equipment, Wi-Fi, and/or other telecommunications for the duration of the program.
5. All Entries must be submitted with the following:
  - Online Application Form
  - Resume (PDF)
  - Rules & Conditions Form (PDF)
6. All Entries must be submitted electronically at [www.peakpasifika.org/ppef](http://www.peakpasifika.org/ppef) with all forms and scripts in PDF format.
7. All Entries are due electronically by Monday September 16, 2024 at 11:59 PM PT .
8. The fellows will be chosen by a Selection Committee of Entertainment Industry Professionals, at such Committee's sole discretion. The fellows will be announced in or around September/October 2024 on the official PEAK website at [peakpasifika.org](http://peakpasifika.org) or the Instagram page [www.instagram.com/peakpasifika](http://www.instagram.com/peakpasifika).
9. Each fellow will receive a multi-week intensive fellowship and a certificate upon completion.
10. The Entrant/Team hereby indemnifies PEAK and its successors, licensees and assigns, and their respective officers, members, employees, agents, representatives and designees (including those acting as judges and mentors) from and against any and all claims, losses, damages, costs, expenses, judgments, awards, settlements, or other liabilities of any kind (including, without limitation, reasonable attorneys' fees and costs) that may be asserted in connection with the script submission.
14. If the submission is by a team, each team member must sign all forms and submit the requested information.
11. All fellows agree to participate in all virtual classes and lab sessions. All fellows irrevocably grant to PEAK, its licensees, successors, assigns and designees, the right to: (a) photograph, film, tape and/or otherwise record their name, image, likeness, voice and biographical data (collectively, "Name, Etc.") which photographs, films, tapes and other recordings (collectively, "Recordings") shall be the sole and absolute property of PEAK; and (b) reproduce, exhibit, perform, publish, display, portray, depict, use and otherwise exploit the Recordings, their Name, Etc., and the submitted material, in whole or in part, in any and all media now known or hereafter devised, throughout the universe, in perpetuity, in connection with PEAK, the PEAK Writers Fellowship, and/or the advertising, promotion and publicity thereof.
12. Each Entrant/Team shall execute such further documents, and take any such actions, as required by PEAK in connection with this fellowship program, within five (5) days of request. If the Entrant/Writer/Team fails or refuses to sign such documents or take such actions, then such Entrant/Writer/Team may be disqualified and PEAK may, in its sole discretion, select an alternate finalist or deny awarding any prize(s).
